

Permit Application For Supervised Public Display of Pyrotechnics

In accordance with KRS 227.710, a permit must be obtained for the public display of pyrotechnic devices or pyrotechnic materials before a proximate audience, whether indoors or outdoors. The permit is granted at the sole discretion of the local official having jurisdiction. In cities the chief of the fire department, or mayor, or similar official where there is no fire department, and in counties outside of cities the county judge/executive, may grant permits for supervised public displays of fireworks and pyrotechnics.

The following information and diagram shall be provided with permit application:

1. A picture ID and resume of the pyrotechnic operator and all assistants;
2. Description of the operator's experience with these devices;
3. Certificate of insurance for the production. (*\$1,000,000 Bond Minimum in accordance with KRS 227.720*);
4. Names, types, size and quantities of devices;
5. Description of any onsite assembly of devices;
6. Place and manner of storage for pyrotechnic devices;
7. A diagram, cut sheets and listings on each type of Flame Effect device;
8. Material Safety Data Sheets (MSDS) for the Pyrotechnic Materials to be used;
9. Certification that the set, scenery, and rigging materials are flame retardant or equivalent. Include any clothing worn by operators, assistance and performers; and
10. Diagram of the grounds or facilities where the production is to be held indicating the following:
 - A. Location of control equipment or fire location;
 - B. Location of devices and approximate distance to audience;
 - C. Identify each device type, method of placement and elevation; and
 - D. Fallout radius of each device used in the production.

Indoor/Outdoor display of pyrotechnics before an approximate audience shall comply with NFPA 1126 (2006 edition); Flame Effect devices shall comply with NFPA 160 (2006 edition).
