

# Permit Application For Supervised Public Display of Fireworks

In accordance with KRS 227.710, a permit must be obtained for the public display of pyrotechnic devices or pyrotechnic materials before a proximate audience, whether indoors or outdoors. The permit is granted at the sole discretion of the local official having jurisdiction. In cities the chief of the fire department, or mayor, or similar official where there is no fire department, and in counties outside of cities the county judge/executive, may grant permits for supervised public displays of fireworks and pyrotechnics.

1. Complete resume of the Operator's Experience and copy of Bureau of Alcohol, Tobacco Firearms and Explosives (ATF) License;

Diagram of fireworks display (a diagram must be attached to this application showing the point at which the fireworks are to be discharged, the location of all buildings, highways and other lines of communication, the lines behind which the audience will be restrained and the location of possible overhead obstructions);
3. Surety bond or evidence of liability insurance deemed adequate by the official to whom application for the permit is made (*\$1,000,000 Bond Minimum in accordance with KRS 227.720*);
4. Approximate number and type of fireworks to be displayed; and
5. Description of manner and place of storage of fireworks prior to delivery to outdoor display site.
