The Department of Housing, Building and Construction started the review process of adopting new versions of the Kentucky Building Code ("KBC") and Kentucky Residential Code ("KRC"). Two task forces have been established, the KBC task force and the KRC task force. The task forces are currently reviewing the 2018, 2021 and 2024 editions of the International Building Code and International Residential Code to identify significant changes between those codes and the current adopted editions of the KBC and KRC and make recommendations to the Department regarding code amendments and adoption of new editions of the KBC and KRC codes.
